- **6.** Effective complaints management Processes for raising concerns & complaints are responsive, understood, accessible & used by children, families, carers, communities & personnel
- 7. Ongoing education and training
 Personnel are equipped with knowledge, skills &
 awareness to keep children safe through information,
 ongoing education & training
- 8. Safe physical and online environments
 Physical & online environments promote safety & contain
 appropriate safeguards to minimise the opportunity for
 children to be harmed
- **9. Continuous improvement**Entities regularly review & improve implementation of their systems for keeping children safe
- 10. Policies and procedures support child safety
 Policies & procedures document how the entity is safe for
 children

The National Catholic Safeguarding Standards harmonise with the National Principles for Child Safe Organisations which build on the Child Safe Standards recommended by the Royal Commission into Institutional Responses to Child Sexual Abuse.

CPSL was established in 2016 by the Australian Catholic Bishops Conference and Catholic Religious Australia in response to the Royal Commission into Institutional Responses to Child Sexual Abuse.

CPSL functions independently and fosters a culture of increasing transparency and accountability in the Church.

CPSL acknowledges the lifelong trauma of abuse victims and survivors and their families; the failure of the Catholic Church to protect, believe and respond justly to children and vulnerable adults; and the consequent breaches of community trust.

About CPSL

CPSL has five core functions:

- Set safeguarding standards to ensure the safety of children & vulnerable adults who engage with the Church at any level anywhere in Australia
- Provide training & support to enable Church authorities, entities, organisations, ministries & anyone involved in the Church to create a culture of safety for everyone
- Support the Church to build a culture of safeguarding
- Audit the compliance of Catholic entities, organisations
 & ministries in accordance with the Standards
- Publicly report the results of those audits

Broadly speaking, these five functions mean CPSL performs both an audit & compliance function (assessing & reporting on compliance across entities) & a capacity building function (educating, advising & researching to support compliance & promote continuous improvement).



Safeguarding is everyone's responsibility

The National Catholic Safeguarding Standards are designed to be implemented by all Catholic entities, ministries & organisations across Australia.

They constitute a framework which articulates requirements for Catholic entities to promote the safety of children through the implementation of policies & activities to prevent, respond to & report concerns regarding child abuse.

They are designed to drive cultural & behavioural change & promote accountability & transparency of Catholic Church leaders, their ministries & entities.

All children have the right to be safe all the time.

Every individual engaged with any ministry or activity of the Catholic Church has a responsibility to do their part to keep children safe.

Every Catholic entity, ministry & organisation needs to take deliberate steps to protect children from physical, sexual, emotional & psychological abuse. Culture & policies are important enablers of child safety, & they need to both expect & support action. Responsibility for taking action to prevent child abuse & to raise concerns must be understood & accepted by everyone.

The work involved in building & maintaining a safe Church is never completed. It requires a dynamic, multi-pronged & ongoing process of learning, acting, monitoring & reviewing.

It is critical that the ten National Catholic Safeguarding Standards are understood to be inter-related & inter-dependent. Over-reliance on any one component risks compromising the development of a robust child safe environment & may result in weaknesses which could be exploited.

Quick facts about audits

- The audit process looks at the safeguarding practices of dioceses, religious institutes, associations & ministerial public juridic persons
- The audit process is tailored to the unique circumstances of each entity
- During the audit process, the CPSL auditors 'sample' a range of ministries - for example, in dioceses, we seek to visit up to a quarter of parishes & in religious institutes we seek to interview up to a quarter of members of the institute. We also meet with & review a range of ministries providing services involving children such as children's liturgists, altar servers & youth ministry leaders
- The audit process is designed to identify gaps as well as good practices across the range of ministries offered
- Audit reports include recommendations for improvement for the entity & a list of agreed actions for the bishop, leader or management to act upon
- Audit reports are published on the CPSL website visit 'Safe Church > Church Reports'
